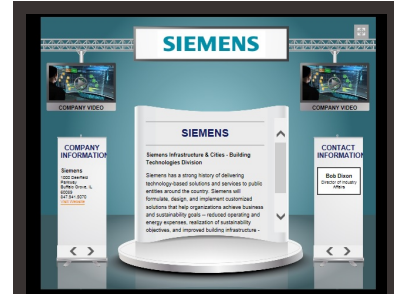
Facility Retrofits for Energy Efficiency (FREE)

On May 7th NYSERDA and its partners hosted a one-day workshop in Albany to support the state's new Green



Bank. The workshop also included the launch of the New York ESC Chapter. We welcome New York to the growing ranks of ESC State Chapters. This issue of the ESC Monthly Newsletter will shine a light on ESC in the Empire State.

New York: The Saugerties Village Board voted unanimously to enter into an energy performance contract with a base cost of \$1,535,036 and a maximum cost of \$1.7 million. The contract calls for the replacement of all the water meters in the village with radio-read meters. The current water meters are mechanical meters that have been in place for 20 to 25 years. Over time, those meters lose accuracy and the meters replacement would be more of a revenue enhancement for the village, rather than energy savings. The village is expected to receive between \$80,000 and \$90,000 annually in energy savings and additional revenues.

New York: Ithaca City School District (ICSD) will decide at its June school board meeting whether to enter into an ESPC based on a recently completed investment grade audit

New York: A report by the New York State Comptroller's Office notes that Schoharie Central School District is realizing significant savings through an energy performance contract, without the use of state aid or other grants to fund the program. Schoharie Central projects a savings of \$2.19 million dollars in energy costs over the life of its contract.

New York: The New York State Education Department has put its stamp of approval on an ESPC project designed to make Highland's school buildings more energy efficient. The energy consumption savings realized through the identified improvements will fully cover the project's cost of \$1.63 million.

New York: Fulton County government is considering signing a 15 year \$1.2 million contract to upgrade energy infrastructure needs throughout county buildings.

New York: Nassau County has issued an RFP to implement energy efficiency projects at County facilities through an ESPC. The County owns and maintains hundreds of structures and properties ranging from low and mid-rise office buildings, parks and infrastructure-related facilities of varying size.

ELSEWHERE . . .

Missouri: City of Kirksville has completed a \$4.7 million ESPC that is expected to provide the city more than \$340,000 in annual savings over the 15-year contract. The most significant project component is the replacement of the city's 7,000 aging water meters and water system. Kirksville historically had problems with water loss within the system; the new meters will allow the city to limit rate increases and make the billing process more accurate, which will directly benefit city residents.



Cole County has entered into a \$1.2 million ESPC that includes building renovations and expansion of the existing County Emergency Medical Services facility. Upgrades to the building infrastructure and energy efficiency improvements within the 9,000 square foot facility are expected to save the County more than \$89,000 in annual energy and operational costs.

A number of other ESPC projects have been completed in Missouri recently including Riverview Gardens School District, University City School District, Hazelwood
