New Mexico Awarded 2016 ESC Energy Stewardship Award

August 11, 2016: ESC President Tom Walther, presented the first ESC Energy Stewardship Awards to 10 states at the 5th Annual Market Transformation Conference. Awards. New Mexico was recognized for a combination of the state's leadership, programmatic design, and the amount of private sector investment in guaranteed energy savings performance contracting in the state.

To date, more than \$43 million in energy savings projects have been implemented in New Mexico as a result of a GESPC.

New Mexico's Commitment to GESPC Recognized by US DOE

Dr. Kathleen Hogan, Deputy Assistant Secretary for Energy Efficiency, U.S. Department of Energy, recognized New Mexico during the 5th Annual ESC Market Transformation Conference for their efforts in promoting Guaranteed Energy Savings Performance Contracting. Dr. Hogan recognized the New Mexico for its partnership in the DOE's ESPC Accelerator Program, and the state's \$50 million pledge toward reaching the Department's \$2 billion goal for public-sector energy efficiency GESPC investments at the state and local level. The \$2 billion goal covers the period from January 2013 to December 2016.

What Success Looks Like: New Mexico-Style

November 2016 * New Mexico State University is expected to save more than \$1.3 million annually thanks to an energy performance contract. The project's construction, which was completed in December 2015, has allowed NMSU to generate 51 percent of its own power from its new solar array during the 2016 fiscal year, meaning the university has produced more power than it has bought from El Paso Electric. NMSU has also reduced electricity and natural gas consumption, and reduced the production of 24.9 million pounds of carbon dioxide.
